The family and patient are able to handle the needs and care of the patient with assistance from the hospice team. Continuous Care - Skilled nursing services are provided in the patient's home to help manage a patient crisis. Inpatient Care - This care is provided in a facility (hospital, inpatient unit or nursing home) for symptoms or crises that cannot be managed in the patient's home.
